

To Competent Authority

Under Article 6 and 12 of the Special Act on Imported Food Safety Control, the Korean Ministry of Food and Drug Safety(MFDS) had annually conducted on-site inspections of overseas food manufacturing facilities and establishments in an effort to prevent hazards of imported foods.

This year, however, the on-site inspection was replaced with a document review as the COVID-19 adversely affected the world. As such, MFDS requested submitting results of an on-site audit conducted by either a business itself or your competent authority, noting that the manufacturer will face tightened inspections at customs clearance and be placed on an on-site inspection list for 2021 if there is no submission.

Attaching a list of facilities(establishments) that have failed to submit requested documentation for the 2020 document review, MFDS informs you that the listed businesses will be subject to intensified customs inspections and an on-site inspection for 2021
